TD BEACH TO BEACON 10K VOLUNTEER RELEASE

I acknowledge that (i) by volunteering in connection with the TD Beach to Beacon 10K Road Race (the "Event"), I will not be supervised in any way by TD Beach to Beacon 10K, Inc. TD Bank, N.A. and its affiliates and subsidiaries, Joan Benoit-Samuelson, Dave McGillivray Sports Enterprises Inc., USA Track & Field, Inc. or sponsors, coordinating groups, promoters, volunteers, or any individuals associated or affiliated in any way with the sponsorship, promotion, or execution of the Event (hereinafter collectively referred to as "Releasees"); (ii) volunteering during a road race is a potentially hazardous activity; (iii) I assume all risk associated with volunteering during the Event, including, but not limited to falls, contact with participants or volunteers, the effects of weather including high heat or humidity, traffic, the conditions of the road, and the possibility of serious physical and/or mental trauma or injury, including permanent disability and death, all such risks being known and appreciated by me; and (iv) in consideration of being permitted to volunteer during the Event, for myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I hereby release, discharge, hold harmless and promise to indemnify the Releasees, their officers, directors, members, representatives, successors, heirs, and assigns, from and against all rights and claims, including claims arising directly or indirectly from the Releasees' own negligence, which I have or which may hereafter accrue to me, and any and all damages that may be sustained by me directly or indirectly in connection with, or arising out of, my participation in the Event. I agree, for myself and my Successors, that if I or my Successors assert any claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal costs and attorneys' fees) incurred by the other party or parties in defending any such claim. This release is intended to be a complete and unconditional release of all liability to the greatest extent allowed by law.

I understand that the Event is widely publicized and photographed. I hereby irrevocably grant full permission to the Releasees to use photographs, videotapes, motion pictures or any other record of this event, including any of the foregoing that include me and my name, likeness and/or voice, for any legitimate purpose, and I further irrevocably grant such parties full permission to perpetually use, edit, reproduce, transmit, distribute, publish, display, and/or perform, in whole or in part and without the need for paying a royalty, any of those photographs, videotapes, motion pictures or record of the event that include my name, likeness, voice, statements, and general biographical information (e.g. residence city and state or province), singularly or in conjunction with other photographs and recordings, for advertising, publicity, commercial or any other business purposes without limitation as to time, territory or medium.
